

TOWNSHIP OF WINFIELD ORDINANCE NO. 2011-05

AN ORDINANCE OF WINFIELD TOWNSHIP, BUTLER COUNTY, PENNSYLVANIA, AUTHORIZING WINFIELD TOWNSHIP TO ENTER INTO AN ADDENDUM TO THE INTERMUNICIPALITY AGREEMENT BY AND BETWEEN WINFIELD TOWNSHIP, THE MUNICIPAL AUTHORITY OF BUFFALO TOWNSHIP ("MABT"), AND BUFFALO TOWNSHIP, ADOPTED BY ORDINANCE NO. 09-01.

WHEREAS, Winfield Township, Buffalo Township, and MABT have entered into a Intermunicipality Agreement dated March 11, 2009, which was approved by Winfield Township by the adoption of Ordinance No. 09-01; and,

WHEREAS, Winfield Township, Buffalo Township and MABT mutually desire to enter into an Addendum to the Intermunicipality Agreement to permit MABT to provide sanitary sewage service to a property in Winfield Township identified as Tax Parcel No. 320-1F94-16, and specifically for one residential dwelling and two commercial buildings on such property;

Accordingly, the Board of Supervisors of Winfield Township, Butler County, Pennsylvania, does hereby Ordain and enact the following Ordinance.

SECTION 1:

The Board of Supervisors of Winfield Township, Butler County, hereby approves and adopts the Addendum to the Intermunicipality Agreement by and between Winfield Township, Buffalo Township, and MABT, a true and correct copy which is attached hereto and is incorporated herein by reference as Exhibit A.

SECTION 2:

The Chairman of the Board of Supervisors of Winfield Township and the Supervisors be and hereby are authorized and directed to execute the attached Addendum Agreement on behalf of Winfield Township and the Township Secretary is authorized and directed to attest to the execution of said Addendum Agreement.

SECTION 3:

In the event any provision, section, sentence, clause or part of this Ordinance or any of the attached Agreement shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, sentence, section, clause or part of this Ordinance or the attached Agreement approved by the adoption of this Ordinance, it being the intent of Winfield Township that such remainders shall be and shall remain in full force and effect.

SECTION 4:

This Ordinance shall become effective five (5) days following its adoption by the Board of Supervisors of Winfield Township and the attached Agreement shall become effective only upon approval and ratification by the respective parties to said Agreement.
