ORDINANCE NO. 387

AN ORDINANCE LIMITING, REGULATING, AND
RESTRICTING SPEED OF MOTOR VEHICLES UPON
CERTAIN ROADS IN WINFIELD TOWNSHIP.

BE IT ORDAINED AND ENACTED by the Board of Supervisors
of Winfield Township, Butler County, Pennsylvania, and it is hereby ordained
and enacted by the authority of the same;

SECTION I. It is deemed beneficial to the Township of
Winfield, and the peace, safety, and welfare of the residents thereof that
speed limits be imposed on the following roads located in Winfield Township:

SECTION II. All appropriate signs listing said speed limit
shall be displayed according to the general speed regulations ordinance
(Ordinance #781) of the TOWNSHIP OF WINFIELD.

SECTION III. Any person violating any of the provisions
of this ordinance shall, upon summary conviction thereof before any District
Magistrate, be sentenced to pay a fine of Ten (\$10.00) dollars and cost of
prosecution for each offense, the same to be for the use of the Township of
Winfield and to be collected as fines and penalties are now by law collectible.

ORDINANCE NO. 387

SECTION IV. This ordinance shall go into effect five (5) days after its enactment or adoption.
