

WINFIELD TOWNSHIP

ORDINANCE NO. 404

AN ORDINANCE OF WINFIELD TOWNSHIP, BUTLER COUNTY, PENNSYLVANIA, PROVIDING FOR PROHIBITION OF PARKING OF MOTOR VEHICLES ON CERTAIN STREETS SITUATED IN WINFIELD TOWNSHIP AND FOR PENALTIES FOR VIOLATION OF THE SAME.

The Board of Supervisors of Winfield Township, Butler County, Pennsylvania do hereby ordain and enact, pursuant to Section 2328 of the Second Class Township Code, 53 Pa.C.S. § 67328, 75 Pa. C.S. § 6901(a)(22), and 67 Pa. Code § 201.21(g), the following Ordinance:

SECTION 1: PARKING PROHIBITED

No person shall park a vehicle at any time upon any of the following streets or parts thereof, including the shoulder of said street:

Gray Avenue	both	Entire length
Winfield Road (State Route 2010)	both	From segment 0240/off 2360 to the intersection of Helmbold Avenue (T-843)/ Segment 0240/off 2550

Proper signs shall be erected to notify operators that no parking is permitted within these prohibitions.

SECTION 2: FINES

Any person who violates any provision of this Ordinance shall, upon conviction, be sentenced to pay a fine of not more than \$50.00 and costs; provided, however, that shall be the duty of the police officers of the Township, if any, and/or the Pennsylvania State Police to report all violations of any provisions of this Ordinance, indicating, in each case, the section violated, the license number of the vehicle involved in the violation, the location where the violation took place and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending each violation. The law enforcement official enforcing this Ordinance shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Ordinance.

SECTION 3: APPLICABILITY AND SCOPE

This Ordinance is enacted under the authority of Section 2328 of the Second Class Township Code, 53 Pa.C.S. § 67328, and Section 6109(a)(22) of the Vehicle Code, 75 Pa.

C.S. § 6901(a)(22), and gives the authority to the Township and to the Pennsylvania State Police to remove and impound vehicles that are parked on any street in the Township in violation of this Ordinance. In accordance with Publication 201 (67 Pa. Code Chapter 201), Section 201.21(b)(1) & (2) and Section 201.6(16)(ii), the Board of Supervisors of Winfield Township specifically finds that parking should be restricted on the above - identified segment of State Route 2010 (Winfield Road). Parking on Gray is prohibited due to narrow width of the cart way and the need for Township maintenance vehicles to use and maintain the road.

This Ordinance shall become affective five (5) days following adoption by the Board of Supervisors of Winfield Township.
