ORDINANCE NO. 197

AN ORDINANCE REQUIRING ALL PERSONS, PARTNERSHIPS, BUSINESS CORPORATIONS AND ALL OTHER REALTY HOLDING ENTITIES TO POST AND DISPLAY BUILDING PROPERTY NUMBERS.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Winfield Township, Butler County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same:

SECTION I: It is the intent of this ordinance to:

- A. Establish a uniform system of property/ dwelling/building address numbering within the Township of Winfield in order that there be an accurate address data base for the township's participation in the Butler County Enhanced 9-1-1 System.
- B. Establish a uniform system of posting and displaying address identification numbers in order that property/dwelling/building addresses within the township may be easily located in emergency situations.
- C. Require all owners of each property/ dwelling/building to notify the township when renting/leasing said property/dwelling/ building.

SECTION II: Posting of address identification numbers:

- A. All locations in the township that have been assigned address identification numbers shall post that number within fifteen (15) days of enactment of this ordinance.
- B. All owners and/or occupants of new dwellings or buildings must post the address identification numbers within fifteen (15) days of notification by the township.

SECTION III: Regulations regarding posting and display:

- A. All owners and/or occupants of property/
 dwelling/building shall conspicuously post
 address identification numbers and
 identification number plate at the entrance
 of the driveway to the premises or on the
 structure or dwelling. The identification
 numbers shall be a minimum of three (3")
 inches in size.
- B. The identification number plate shall be mounted a minimum height of three (3') feet from the bottom of the plate from ground.
- C. The identification number plate shall be mounted on display posts such as wood pole, steel rod or masonry pillar. If displayed on a structure or dwelling rather then at the driveway entrance, the number plate must be clearly visible from the road which provides public access to the premises.
- D. Regardless of the type of posting used, the identification number plate must be clearly visible from the road which provides public access to the premises. The view of the plate must not be obstructed by vegetation, trees or any other object(s) or debris.

SECTION IV: Notice to Township:

A. All owners and/or occupants of each property/dwelling/building shall be required to notify the Township of Winfield in writing or person, within seven (7) days or receiving assigned address identification by the township or within seven (7) days of renting/leasing said property/dwelling/building or a portion thereof, and provide the name(s) of the renter/tenant/lessee.

SECTION V: Notice of violation:

A. The Board of Township Supervisors or their designated representative for that purpose is hereby authorized to give written notice to the property owner or occupant of any premises found to be in violation of any section of this ordinance. Such written

notice shall direct and require the property owner or occupant to post the address identification number plate and to comply with the provisions of this ordinance within fifteen (15) days after issuance of such notice.

B. Failure of any owner or occupant to comply within the period of time stated herein, the Township of Winfield or its designated representative for that purpose, may post a street number on the premises and collect the cost thereof, together with any additional penalty authorized by law, from such owner or occupant in the manner provided by law.

SECTION VI: Violations and penalties:

Any owner, owners or occupants who shall violate or fail, neglect or refuse to comply with any of the provisions of this ordinance shall, upon conviction thereof, be sentenced to pay a civil penalty of not more than Six Hundred (\$600) Dollars, provided that each day's violation shall constitute a separate offense; and notice to the offender shall not be necessary in order to constitute an offense for subsequent days.

SECTION VII: Effective date:

This ordinance shall go into effect five (5) days after its enactment or adoption.
